**Anniversary Steps:**

- A. \* At the beginning of the fifteenth (15th) year of service as a certificated employee in the South Pasadena Unified School District, a Unit Member shall receive an anniversary increment of \$200 in addition to the annual salary he/she would receive on the above schedule for the school year. Additionally, in the 15th, 20th, 25th, and 30th years, the allocation would increase to \$1000.00
- B. \* An additional \$200 will be added annually each year of service above (15) years of service.
- C. \* Additionally, in the 15th, 20th, 25th, and 30th, years, the allocation will increase to \$1,000.
- D. \* For purposes of determining consecutive years of service, the following examples shall not disqualify the employee from receiving an anniversary increment: (1) separation from service with the District if the employee is rehired within 39 months of the effective date of separation (2) exercise of leave of absence rights (paid or unpaid) if such leave is designated in this agreement as counting toward step advancement on the basic salary schedule.

School psychologists shall be paid at a level of ten (10) percent above their placement on the certificated salary schedule. Placement shall be based on training (college or university course work) and years of service in SPUSD.
